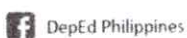
Pursuant to **DepEd Memorandum No. 007, s. 2026** titled **Administration of the Qualifying Examination in Arabic Language and Islamic Studies (QEALIS) in the First Quarter of 2026**, the following are guidelines shall be observed:

1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), will administer the QEALIS on **April 12, 2026**.
2. The updated list of testing centers, along with their respective allocations based on the registration data, is presented in Table 1.

Note that there has been a change in the testing center in Region I, from SDO Ilocos Sur to SDO San Fernando City.

Registered individuals residing in the Bangsamoro Autonomous Region in Muslim Mindanao may take the examination at the designated testing centers listed in the table.

3. Each testing center shall only accommodate registrants as indicated in the allocation. The Registration Number indicated in the Registration Form shall serve as the reference for identifying those who will be accommodated. Registered and qualified individuals who cannot be accommodated in the upcoming QEALIS administration shall be given priority in the next administration.

4. Only the qualified registrants listed in Form 1 (Enclosure No. 2 to the DepEd Memorandum No. 007, s. 2026) that the Regional Testing Coordinators (RTCs) *CR*

submitted to BEA shall be accommodated as examinees. Strictly no walk-in registrants will be accommodated on the examination day.

5. Prior to the test administration, a **virtual orientation** shall be conducted on **March 23, 2026**. This orientation shall be attended by the Regional and Division Madrasah Education Program (MEP) Coordinators, RTCs, Division Testing Coordinators, Supervising Examiners, and Room Examiners. Meeting details will be sent to the Regional MEP Coordinators and RTCs.

6. To ensure the orderly administration of the QEALIS, this issuance reiterates Items 9 and 10 of DepEd Memorandum No. 007, s. 2026:

(9) The RTCs of the testing centers, in collaboration with the Regional MEP Coordinators, shall release a Regional Memorandum regarding the following details:

- a. List of qualified registrants;
- b. Details about the test administration, such as the identified specific venue and examination schedule of qualified registrants; and
- c. Contact information of the key testing personnel.

The SDOs shall subsequently issue a Division Memorandum in connection with the Regional Memorandum.

(10) Prior to the test administration, registrants and involved testing personnel shall review the materials accessible through this link: **<https://bit.ly/DepEdQEALIS>**. The Google Drive folder accessible via the link shall also be used to post the contact details of point persons for activities and announcements related to the examination.
