**2026 NATIONAL MARKET SCOPING ACTIVITY OF
SUPPLEMENTARY LEARNING RESOURCES (SLRs)
IN PARTNERSHIP WITH THE NATIONAL BOOK
DEVELOPMENT BOARD (NBDB)**

To **Schools Division Superintendents**

1. The Department of Education (DepEd), through the Bureau of Learning Resources (BLR), will conduct the National Market Scoping Activity of Supplementary Learning Resources (SLRs) in Partnership with the National Book Development Board (NBDB).
2. The BLR activity will be held on March 11-13, 2026, while the Philippine Book Festival will run from March 12-15, 2026, at Megatrade Hall, SM Megamall, Ortigas Center, Mandaluyong City. The accommodation covers the stay from March 11-13, 2026 within NCR to be specified in separate advisory.
3. For the Regional Office, the Learning Resource (LR) Education Program Supervisor and the Regional Librarian are required to attend the activity. For the Schools Division Offices (SDOs), the participants shall primarily be the Hub Librarian and/or the SDO Librarian, depending on the available slots. In case of unavailability, the LR Supervisor may designate a representative to attend. The officially identified participants for the said activity are listed in Enclosure 1.
4. Online Training sessions in coordination with the NBDB were successfully conducted last February 19, 27, 2026, and March 2, and 5 2026.
5. Expenses for board and lodging shall be charged against BLR Funds. On the other hand, travel expenses shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
6. Other DepEd Personnel aside from the identified participants may attend the PBF at their own expense.
