The Bureau of Learning Resources (BLR) will conduct a **National Market Scoping for Supplementary Learning Resources (SLRs)** in partnership with the National Book Development Board (NBDB) from 11-13 March 2026 at a venue within the National Capital Region. Participants will also join a scoping activity for DepEd and other institutional buyers that will take place as part of the PBF.

It is also requested that Compensatory Time Off (CTO) or leave credit(s), whichever is applicable, be given to personnel attending activities that fall on weekends and holidays.

The first meal shall be lunch on Day 1, 11 March 2026. The last meal shall be lunch on Day 3, 13 March 2026.
