INVITATION TO BID

**Procurement of Uniforms for the Participation of DepEd Region IV-A
CALABARZON in the 2026 Palarong Pambansa**

- 1) The **DEPARTMENT OF EDUCATION REGION IV-A CALABARZON** through the **Government of the Philippines under FY 2026 General Appropriations Act** intends to apply the sum of **Five Million Four Hundred One Thousand One Hundred Seventy Two Pesos and Fifty Centavos (Php5,401,172.50)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Uniforms for the Participation of DepEd Region IV-A CALABARZON in the 2026 Palarong Pambansa**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The **DEPARTMENT OF EDUCATION REGION IV-A CALABARZON** now invites bids for **Procurement of Uniforms for the Participation of DepEd Region IV-A CALABARZON in the 2026 Palarong Pambansa**. The award shall be given to the bidder with the Lowest Calculated Responsive Bid (LCRB) following the procedures under Section 61 and 63 of IRR of Republic Act No. 12009. Delivery of the Goods is required **on or before May 23, 2026**. Bidders should have completed, at least **five (5) years** from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4) Interested Bidders may obtain further information from **Department of Education Region IV-A CALABARZON, BAC Secretariat** and inspect the Bidding Documents at the address given below from **8:00am to 5:00pm**.
- 5) A complete set of Bidding Documents may be acquired by interested Bidders on **April 16, 2026 to May 6, 2026** from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php10,000.00)**.

- 6) The **DEPARTMENT OF EDUCATION REGION IV-A CALABARZON** will hold a Pre-Bid Conference on **April 24, 2026 at 10:00 in the morning** at **DepEd Region IV-A CALABARZON, Gate 2 Karangalan Village, Cainta, Rizal** and/or through video conferencing via **<https://teams.microsoft.com/meet/49360250661064?p=HrxQ39l33yBW1SVFFX>**, which shall be open to prospective Bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before **May 6, 2026 at 9:45 in the morning**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) Bid opening shall be on **May 6, 2026 at 10:00 in the morning** at **DepEd Region IV-A CALABARZON, Gate 2 Karangalan Village, Cainta, Rizal**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) The **Department of Education Region IV-A CALABARZON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
