

**CALL FOR THE PARTICIPATION OF SPIMS INCUMBENT

NATIONAL REINTEGRATION NETWORK  
(BBM-NRN) FAIR**

To: **Schools Division Superintendents**

The Department of Education (DepEd), through the Human Resource and Organizational Development and Infrastructure (HRODI) Strand, encourages the participation in the *“Bayanihan para sa Balikbayang Manggagawa”*: A **National Reintegration Network (BBM-NRN) Fair**, spearheaded by the Department of Migrant Workers (DMW), on April 13, 2026 (Monday).
