**REGIONAL TRAINING OF TEACHERS ON STRENGTHENED
SENIOR HIGH SCHOOL CURRICULUM**

To: **Schools Division Superintendents**

1. In preparation for the full implementation of the **Strengthened Senior High School Curriculum**, this Office, through the Human Resource Development Division-National Educators Academy of the Philippines (HRDD-NEAPR) in the Region, in collaboration with Curriculum and Learning Management Division (CLMD) and Quality Assurance Division (QAD), shall conduct the **Regional Training of Teachers on the Strengthened Senior High School Curriculum** on **May 19-22, 2026**, at venues to be determined in a separate issuance.
2. By the end of the training, teachers are expected to:
 - a. explain key features and standards of the strengthened Senior High School (SHS) curriculum;
 - b. apply appropriate pedagogical strategies that are learner-centered, inclusive, and responsive to diverse learning needs, aligned with the strengthened SHS;
 - c. develop and align instructional materials, including lesson plans and learning resources, that are contextualized and anchored on strengthened SHS curriculum standards;
 - d. design assessment tools that measure higher-order thinking skills and authentic performance tasks consistent with curriculum goals; and,
 - e. develop Workplace Application Plans for effective classroom-level implementation of the strengthened SHS curriculum.
3. Participants in the training shall be selected Senior High School teachers from the 25 Schools Division Offices (SDOs) who demonstrate strong content mastery and pedagogical expertise in their respective learning areas. They shall serve as trainers, should there be upcoming trainings in other governance levels. Participation shall be on a voluntary basis.
4. Attached is the breakdown of the number of participants per Schools Division Office (SDO). Each SDO, through the Curriculum Implementation Division
