**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO BICOL GARMENTS AND GENERAL MERCHANDISE FOR THE PROCUREMENT OF UNIFORMS FOR THE PARTICIPATION OF DEPED REGION IV-A CALABARZON IN THE 2026 PALARONG PAMBANSA WITH REFERENCE NUMBER ROIVA-26-01**

**WHEREAS**, on April 16, 2026, DepEd Regional Office IV-A CALABARZON has published its procurement activity for the **PROCUREMENT OF UNIFORMS FOR THE PARTICIPATION OF DEPED REGION IV-A CALABARZON IN THE 2026 PALARONG PAMBANSA** with reference number **ROIVA-2026-01** in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

**WHEREAS**, on April 15, 2026, the Bids and Awards Committee (BAC), Technical Working Group (TWG), BAC Secretariat and End-user conducted a pre-procurement conference to discuss the said allotment and approved the bid documents for the Procurement of Uniforms for the Participation of DepEd Region IV-A CALABARZON in the 2026 Palarong Pambansa;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **FIVE MILLION FOUR HUNDRED ONE THOUSAND ONE HUNDRED SEVENTY-TWO PESOS AND 50/100 (Php5,401,172.50)**;

**WHEREAS**, Bid Bulletin No. 1, s. 2026 dated April 17, 2026 and Bid Bulletin No. 2, s. 2026 dated April 27, 2026 were issued;

**WHEREAS**, on April 24, 2026, Pre-Bid Conference was held followed by a Bid Submission and Opening on May 6, 2026;

**WHEREAS**, during the bid submission and opening, the BAC received sealed bids, offering the financial bids as read:

**WHEREAS**, using the checklist of required documents and taking into account the non-discretionary "Presence or Absence Criterion", the BAC found that **J&L CREATIVE MINDS CO., RALCO COMMERCIAL TRADING** and **BICOL GARMENTS AND GENERAL MERCHANDISE** have complied with specifications issued by this Office;

**WHEREAS**, upon Bid Evaluation proceedings and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted, the BAC found that **J&L CREATIVE MINDS CO.** and **RALCO COMMERCIAL TRADING** were non-responsive due to non-compliance on the technical specifications required by this office as follows:

**J&L CREATIVE MINDS CO.**

Conformity to Section VII Technical Specifications

- a) No attached delivery schedule and after-sales service/parts;
- b) Color and cloth of actual samples submitted are not compliant with the specifications.

**RALCO COMMERCIAL TRADING**

Conformity to Section VII Technical Specifications

- a) Color of the actual samples of jogging pants does not match with the other sets of uniform; and
- b) No sample shoes presented.

**WHEREAS**, upon Bid Evaluation proceedings and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted, the BAC found that **BICOL GARMENTS AND GENERAL MERCHANDISE** was compliant with the specifications issued by this office;

**WHEREAS**, upon Post-Qualification proceedings and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **BICOL GARMENTS AND GENERAL MERCHANDISE** has been found to be responsive;

**WHEREAS**, the bid submitted by **BICOL GARMENTS AND GENERAL MERCHANDISE** is compliant with its proposal in the total amount of **FOUR MILLION FIVE HUNDRED FORTY-ONE THOUSAND SIX HUNDRED FIFTY PESOS (Php4,541,650.00)**;

**WHEREAS**, after review and deliberation on the proposal, **BICOL GARMENTS AND GENERAL MERCHANDISE** complied with the requirements and is hereby declared as the Single Calculated and Responsive Bid (SCRB);


**NOW, THEREFORE**, the BAC hereby **RESOLVES** as it hereby **RESOLVED**:

1. **To DECLARE J&L CREATIVE MINDS CO. and RALCO COMMERCIAL TRADING** as ineligible bidder for being non-responsive and non-compliant to the specifications and standards set by this office;
2. **To DECLARE BICOL GARMENTS AND GENERAL MERCHANDISE** as the eligible bidder and being post-qualified after thorough Post-Qualification

proceedings having the Single Calculated and Responsive Bidder (SCRB) in the amount of **FOUR MILLION FIVE HUNDRED FORTY-ONE THOUSAND SIX HUNDRED FIFTY PESOS (Php4,541,650.00)**; and


3. **To RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the **award of contract to BICOL GARMENTS AND GENERAL MERCHANDISE** for the Procurement of Uniforms for the Participation of DepEd Region IV-A CALABARZON in the 2026 Palarong Pambansa with reference number ROIVA-2026-01 in the amount of **FOUR MILLION FIVE HUNDRED FORTY-ONE THOUSAND SIX HUNDRED FIFTY PESOS (Php4,541,650.00)**.


