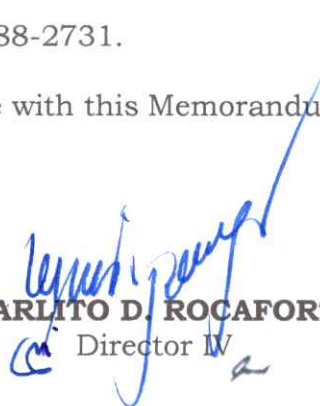

To: **Schools Division Superintendents**

1. In reference to DepEd Order No. 52, s. 2015¹, this Office through the Field Technical Assistance Division will conduct a Training Workshop in Strengthening Strategic Capacity of Field Offices in the Delivery of TA Interventions (Blended) on June 18, 2026 at the Bulwagan ng Karangalan and via MS Teams.
2. The activity aims to:
 - a. review and validate the existing Regional Comprehensive TA Plan for School Operations and Management, anchored on the six (6) SBM dimensions, and ensure alignment with DepEd's shared governance and field-office support functions;
 - b. generate and synthesize critical inputs (gaps, priorities, interventions, timelines, responsible units, and monitoring indicators) to strengthen and refine the Comprehensive Regional TA Plan, consistent with the principle that field offices translate policy into context-responsive programs and services; and
 - c. finalize and agree on the Comprehensive Regional TA Plan, including TA delivery mechanisms, coordination arrangements, and reporting/feedback processes, in support of accountable and coordinated implementation.
3. The participants in this activity from the regional office are the Functional Division Chiefs and Representatives while from the SDOs are the SGOD Chiefs, CID Chiefs, and SBM/SGC Coordinators.
