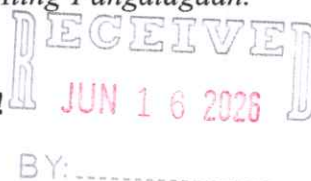
Dear **Director Rocafort**:

Greetings from the National Nutrition Council (NNC) - CALABARZON!

As you may know, Presidential Decree No. 491, otherwise known as the Nutrition Act of the Philippines, declares the month of July as Nutrition Month and mandates the National Nutrition Council to lead the nationwide campaign. Celebrated annually, it aims to raise public awareness on nutrition by highlighting a selected nutrition issue or focus, to influence positive behaviors, and mobilize multi-sectoral action.

From 2025 to 2028, NM campaigns will carry the overarching theme "Sa PPAN: Sama-sama sa Nutrisyong Sapat Para sa Lahat!" for continuous advocacy in implementing the Philippine Plan of Action for Nutrition (PPAN) 2023-2028. To sustain advocacy efforts and highlight priority areas, a specific sub-theme shall be identified each year, aligned with one of the pillars of PPAN 2023-2028. For 2026, the NNC Technical Committee agreed to make nutrition and climate change the NM focus to emphasize their interconnection and with a sub-theme "Nutrisyon at Kalikasan, Ating Pangalagaan." Hence, the complete 2026 Nutrition Month theme with sub-theme is:

**"Sa PPAN: Sama-sama sa Nutrisyong Sapat para sa Lahat!
Nutrisyon at Kalikasan, Ating Pangalagaan."**



The 2026 National Nutrition Month campaign aims to create greater awareness on nutrition among the public, particularly on the importance of adopting sustainable food systems and dietary practices that promote both human nutrition and environmental sustainability.

In line with this, the 2026 Nutrition Month celebration encourages stakeholders to integrate nutrition and environment sustainability into their programs and activities, and to strengthen multi-sectoral collaboration to advance climate-resilient and nutrition-sensitive initiatives at the community level.

In this regard and as a Member of the Regional Nutrition Committee (RNC) we invite you and your agency to actively participate in this nationwide celebration by disseminating the theme to your agency personnel and networks and, more importantly, by planning and undertaking activities along the NM Theme.
