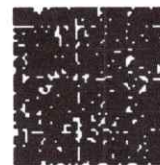

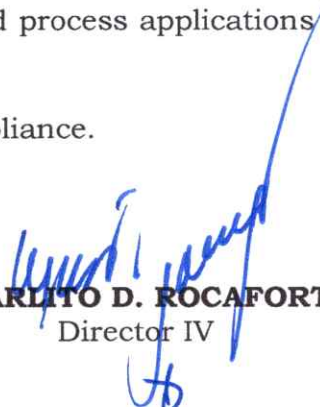

2. Under the new TCAA, accredited private entities may grant up to two (2) regular loans per borrower, in addition to a calamity loan, subject to existing rules and limitations.
3. All concerned payroll and verification personnel in the Central, Regional, Schools Division Offices, and implementing unit secondary schools are directed to process loan verification requests from the above entities in accordance with established guidelines and procedures.
4. The Central Office continues to review and process applications of other entities for accreditation/re-accreditation.
