PAGSASANAY SA EDUKASYONG PANGKULTURA (PEP)

To: **Schools Division Superintendents**

1. In reference to DM-OUOPS-2026-15-00146 titled: Philippine Cultural Education Program (PCEP) 2026 Programs, and letter from the Philippine Cultural Education Program (PCEP), this Office, through the Curriculum and Learning Management Division (CLMD), announces the Pagsasanay sa Edukasyong Pangkultura (PEP) to be conducted by Philippine Cultural Education Program (PCEP) from July 10-12, 2026 (Fri-Sun) in the Metropolitan Theater Ballroom at the Padre Burgos Avenue, corner Antonio Villegas St, Ermita, Manila, 1000 Metro Manila, NCR.
2. This project aims to promote the integration of culture-based education into teaching practices at the basic education level while incorporating decolonization methods.

6. Participants shall shoulder their round-trip transportation, accommodation, and meal expenses. These expenses may be charged to local funds, subject to existing accounting and auditing rules, regulations, and applicable government policies.


