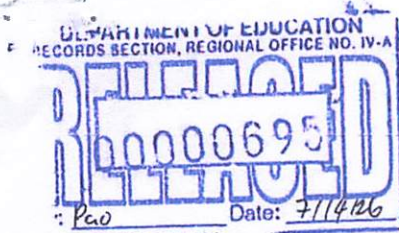

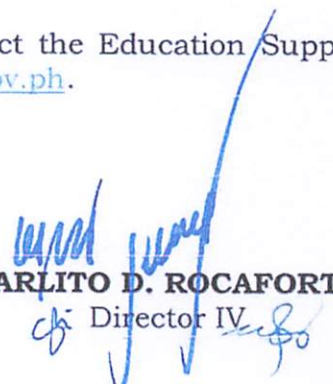

1. In compliance with the DepEd Memorandum No. 027, s. 2026¹, this Office, through the Education Support Services Division (ESSD), hereby announces the conduct of the monitoring of the Schools Division Offices' partnership programs, Brigada Eskwela implementation, and fund utilization of Youth Formation programs in selected schools in the region.
2. The Regional Brigada Monitoring Team, together with the Division Partnership Focal Persons, and Youth Formation Division counterparts, will visit the selected last-mile schools in Tayabas City and Rizal Province to monitor and donate learning materials. The list of selected schools, Partnership Monitoring Tool, and the Brigada Eskwela Monitoring Tool are attached for reference.

The school heads shall ensure the donated items classified as property, plant, and equipment are properly recorded in the book of accounts as stipulated in DepEd Order No. 082, s. 2011², required documents like Inventory Custodian Slip and Property Acknowledge Receipt. Please refer to DepEd Memorandum No. 27, s. 2026, and its enclosure, specifically under the Post Implementation Stage of Brigada Eskwela.
