Pursuant to **DepEd Order No. 40, s. 2014**, Establishment, Merging, Conversion, and Naming / Renaming of Public Schools, and Separation of Public School Annexes in Basic Education, and **DepEd Order No. 71, s. 2003**, Transfer of Delegated Authority from the Office of the Secretary to the Regional Offices Regarding Approval of the Establishment, Separation of Annexes, Integration, Conversion and Renaming of Public Elementary and Secondary Schools, and **DM No. 61, s. 2025** on Dissemination of Omnibus Implementing Rules and Regulation of the Laws on the Establishment of Public Schools in Basic Education, this Office, through the Quality Assurance Division (QAD), directs all concerned on the submission of Status Report of Newly Established Schools approved by the Regional Director and public schools established by virtue of law **on or before July 30, 2026**.

This aims to monitor the operational status of newly established schools, identify schools requiring technical assistance and other appropriate interventions, in compliance with applicable DepEd policies, standards, and guidelines, and maintain an updated regional database of newly established public schools.
