**REGIONAL SCHOOL-BASED FEEDING PROGRAM
IMPLEMENTATION REVIEW**

To **Schools Division Superintendents**

1. In reference to DepEd Order No. 13, s. 2026 dated June 4, 2026¹, this Office through the Education Support Services Division (ESSD) hereby announces the conduct of the Regional School-Based Feeding Program (SBFP) Implementation Review on September 1-3, 2026, at a venue to be announced in a separate issuance.
2. This activity aims to review the SBFP implementation for SY 2025–2026, assess the status of the SY 2026–2027 implementation, provide program updates, and validate and complete SBFP reports.
3. The expected participants are five (5) selected ESSD personnel from the Regional Office and two (2) SBFP focal persons from each Schools Division Office (SDO), consisting of the Main and Alternate SBFP Focal Persons.
