ONSITE VALIDATION FOR DIVISION CATEGORY**

To **Regional PRAISE Committee**

1. With reference to Regional Memorandum No. 445, s. 2026, titled: **"11th DepEd CALABARZON Gawad Patnugot Stage 2 Qualifiers"** this Office, through the Regional PRAISE Committee in collaboration with the Human Resource Development Division (HRDD), announces the conduct of the Stage 2 onsite validation for the Schools Division Office (SDO) category on **August 19, 2026**.
2. Pursuant to the directive of the Top Management, the SDO category shall undergo validation by the Regional Functional Division Chiefs and external validators. Please see attached List of Regional Validators for reference. To ensure the systematic and organized conduct of the validation, the Regional PRAISE Committee shall conduct a virtual orientation for the regional validators on August 14, 2026, at 10 a.m. via MS Teams.
3. Schools Division Office Stage 2 qualifiers are advised to prepare and organize their Means of Verification (MOVs) in accordance with the enhanced Stage 2 criteria for the SDO category.
4. Expenses incurred in the conduct of the activity such as honoraria of the external validators and other related expenses of the regional validators, shall be charged against Regional Funds/local Funds. While meals and other incidental cost of the SDO participating shall be charged against their respective local funds, subject to the usual accounting and auditing rules and regulations.
